**VFT Research on Effects of Energetic Environmental Pollution
 on Human Healing Processes**

**New Understandings on the Effects of Energetic Pollution on the Healing Process
 And Solutions Made Possible with Vital Force Technology™**

This is 10 years of research conducted by Prof. Joie Jones on the effect of Pranic healing on human cells in culture. His research demonstrated the ability of Pranic healers to increase the survival rate of HeLa cells subjected to gamma radiation from the expected 50% for the untreated cells, to over 90% for cells treated by healers both before and after radiation. This healing effect was independent of the distance between the healers and cells. Shielding the cells from EMF and gamma radiation during the healing sessions had no effect on the results.

Most important for our discussion is the observation made by Dr. Jones that the healing effect was dramatically different in “energetically clean” versus “energetically dirty” environments. He conducted his experiments in three laboratories:

- 1) The “conditioned” lab”: a lab that had been regularly cleaned by Pranic healers over a period of 10 years of experimentation.
- 2) The “non-conditioned” lab: a relatively new and well-maintained environment.
- 3) The “dirty lab”: a lab where experiments on dissected animals and other similar experimentation had been conducted over a lengthy period of time.

Here are the results Dr. Jones observed in the three labs:

Dr. Jones’ experiments are the first experiments with human cells that clearly reveal the damaging impact of energetic pollution on the healing process. It is logical to assume that the

human body with its many varieties of cell types is also very sensitive to energetic conditions in the environment. I believe future medical science will be comparing this discovery with Louis Pasteur's discovery about the role of germs and microbes in the causes and prevention of disease that revolutionized health care science in the nineteenth century.

These experiments raise some very important questions with huge implications. Obviously medical clinics, surgical rooms, emergency rooms, psychiatric hospitals, etc., contain energetic pollution. This gives rise to two questions: is it possible to counteract the negative impact of energetic pollution on the healing process, and is there any way to clean an energetically polluted environment? To answer these questions, we decided to set up another series of experiments to further explore the governing laws and properties of this mysterious subtle energy.

Additional goals of our experiments were to shed some light on the energetic mechanism of the "power of intent" of the human mind and to demonstrate that subtle energy is not just a bio-field of the human body but an energy belonging to the Universe like electromagnetic energy.

We had to overcome the following difficulties to take this research to the next level and comply with standard scientific procedures including making it possible to repeat the experiments in any laboratory:

1. Resolve issues of standardization and repeatability of experiments using energetic healing methods.
2. Find a way to counteract the problem of energetic pollution to create conditions where the healing power of subtle energy could be demonstrated consistently.

We were able to resolve all the challenges of standardization and repetition of experiments and to achieve all the above-mentioned goals while complying with the standards of modern experimental science by using a technology I invented and perfected during the last 20 years. I call this technology Vital Force Technology™.

VFT is a three-part process comprised of a tunable plasma-based generator able to generate and formulate subtle energy patterns, a storage system, and an infusing system able to infuse these patterns into almost any substance. The most significant features of VFT that distinguishes it from all other subtle energy technologies are its tunable generator and the ability to do the following:

1. **Generate the energetic blueprints of any of the Periodic Table Elements, which are the building blocks of all substances in the physical world.** VFT makes it possible to utilize the unique healing properties of Periodic Table Elements while escaping the side effects produced by their chemical counterparts; for example, the energetic pattern of Lithium is effective against depression; Germanium supports the immune system, etc.

2. **Reproduce with precision the energetic blueprints of any substance and infuse these energetic blueprints into other (carrier) substances.** This ability makes it possible to dramatically improve the benefits of existing products with energetic imprints derived from rare or expensive materials such as rare herbs, essential oils, or expensive precious stones.
3. **Produce subtle energy patterns with controllable properties defined by Traditional Chinese Medicine as “The Five Elements”.** As a result, VFT has created complex energetic formulas following the time-tested rules used in Traditional Chinese Medicine, for example, energy infused topicals to influence the acupuncture meridians without needles (non-invasive acupuncture).

Over the course of the last 12 years of working with my Vital Force Technology™ I have created a unique and extensive library of subtle energy patterns. Many of them have been tested and verified through practical uses in the healthcare industry, on animals, plants, and cells in-vitro as well as through rigorous scientific testing procedures. Scientific equipment used in testing the subtle energy patterns produced by VFT include Magnetic Resonance Imaging, Heart Rate Variability, and Gas Discharge Visualization devices, Brain Mapping, Raman Spectroscopy, and a wide variety of electro-acupuncture tools. We have a collection of research results available upon request. Our company, Energy Tools International, LLC is marketing about 50 of these energetic formulas to health professionals. A description of the formulas can be found in our catalog.

To pursue the objectives of our research three subtle energy patterns were produced and recorded with the VFT equipment using the following methods:

- a) A healer from the Pranic School of Healing used imagery as the means of transmitting energy. Through a phone connection, the healer directed energy from about 800 miles to my laboratory. The recipient in the lab was holding a glass of liquid concentrated trace minerals for 5 minutes, in a relaxed and thought free state.
- b) A healer from the Cosmo Energetic School of Healing used imagery and verbal commands of channeled energy as the means of transmitting healing energy. She worked from the Moscow area and focused energy directly to another glass of the same minerals while seeing the glass via a Skype connection.
- c) An energy pattern based on the electronically simulated element Erbium known for its influence on cellular health was generated by the VFT generator.


In all three cases the energy patterns were infused into a Ringer solution and the solution was added to petri dishes with HeLa cells that grow in that solution. The same amount of “uncharged” Ringer solution was added to the control samples with radiated and non-radiated cells.

All three energy patterns produced an almost equal (they differed by approximately 4%) increase in the survival rate of cells. For this reason, we are presenting the results averaged with all three

patterns together. We will call these the healing (H) patterns. As in the Pranic healing experiments, the maximum increase in the survival rate of cells in successful petri dishes occurred when the energy infused solution was added before and after the radiation of the cells.

Here are the results of these experiments:

Further, we will discuss only the most successful results when the infused solution was added to petri dishes with cells both before and after radiation. The success rate (the number of Petri dishes with increased survival rate) was very different in the “conditioned”, “non-conditioned” and “dirty” laboratories, again the same as in the Pranic experiments reported by Joie. (See footnote #1 for definitions of lab conditions.)

Here we see the tremendous impact the energetically polluted environment has on the experiments. The results (Table 1) show that energetic pollution literally jams the “energetic programs” capable of dramatically increasing the survival rate of cells subjected to gamma radiation in cleaner energetic environments.

We need to mention that the average percentage of increase in the survival rate in successful experiments was practically the same in the “conditioned” and “non-conditioned” labs: 88.2% and 88.3% but the number of successful experiments was dramatically different.

These results stimulated us to conduct additional experiments aimed at finding ways to protect the healing action of energy patterns infused into Ringer solutions from being destroyed by energetic pollution. At the suggestion of the Russian healer who previously transmitted the energy patterns used in the experiment discussed above, a new “Protective” energy pattern (“P”) was produced. This pattern was transmitted from the Moscow region to Dr. Kronn’s laboratory and recorded by Vital Force Technology™ using the previously described method. The next 45 experiments were conducted in each of the same three labs. This time the Ringer solution added to the experimental samples was infused with the P-pattern along with the healing subtle energy patterns (H).

The presence of protective energy patterns dramatically increased the number of successful experiments in both the “non-conditioned” and the “dirty” labs:

Thus, adding the protective energy pattern made the average increase in the cell survival rate in successful experiments the same in all three labs and made the average overall increase in survival rate in the “dirty” lab statistically significant.

Adding this protective pattern did not change the number of successful experiments in the "conditioned" lab, which is logical to expect, while significantly affecting the results observed in the two labs with the energetically polluted environments.

Having succeeded in creating a "protective" energy pattern we tried to create a "cleansing" pattern that would be able to clean the entire space in the "Dirty" Lab. Using the same protocol that we used for the creation of the "protective" pattern, we made a "cleansing" energetic pattern.

In our first experiments with the "cleansing" energy pattern we used the following method for influencing the space with this energy pattern. The energy was recorded with the VFT equipment in a DVD-Audio format using the highest possible resolution. We played this DVD which lasts 20 minutes (no sound is produced and only the subtle energy of the "cleansing" pattern is emitted) one time and produced the following results:



Note: when Dr. Jones’ lab was being prepared for experiments the first time it took Pranic healers 4 months to condition the lab. An increase in the survival rate of cells was never observed in the “dirty” lab during Joie’s years of experiments with Pranic healers. In our experiment, after the energetic cleansing of the space for 20 minutes, we observed an increase from 0% to 68% of successful experiments in the “dirty” lab.

To determine how long the energetic cleansing is effective Dr. Jones repeated the experiments with radiated cells in all three labs at intervals of three days from the time of the original cleansing.

Here is what we found:

We can see that the continued presence of energetic pollution in the “dirty” lab jams the healing energy much faster than it does in the regular non-conditioned lab. I would like to mention here that we also made a spray infused with “cleaning” energy. We found that this spray cleanses the space very effectively. We are repeating our experiments using the spray as the cleansing agent because it is so easy to use with potential applications for the energetic cleansing of any space, such as labs, offices, hospitals, hotels, etc.


We are pleased to be able to present the first clinical observations of positive results obtained because of cleaning the “energetic” environment using the spray we call “Clean Sweep”. Dr. Jeffrey Marrongelle of Schuylkill BioNutritional Health Clinic reported that after spraying “Clean Sweep” around his patients he observed positive changes in the ANS response measured using Heart Rate Variability (HRV) testing.

In chronically ill people, overly sensitive to EM radiation, he observed a drop-in elevated heart rate up to 20 beats per minute and a decrease in the Sympathetic Nervous System (SNS) response up to 1.5 deviations towards normal. Even in people with no chronic conditions he observed the spray had a calming effect on the SNS up to 1.5 deviations and improved the physical fitness parameters.

These preliminary results demonstrate the necessity for further research to see how cleansing the environment of energetic pollution will impact the results of various healing modalities. We believe that the findings of this research will have important implications for the study and practice of Subtle Energy Medicine.

Conclusions:

- 1. Subtle energy can be programmed for specific purposes** by the trained human mind as well as by the Vital Force Technology™ equipment.
- 2. The “intent” of the human mind can be technologically captured and reproduced** proving that the subtle energy field records and carries the informational content of the “intent” and indicating that subtle energy is an energy belonging to the Universe like electromagnetic energy.
- 3. These results suggest the mechanism of effect involved in Dr. Emoto’s famous experiments with water under the influence of different “intentions”.** When this water was frozen the ice crystals produced were radically different in shape depending on the nature of the intent. In our experiments the ice crystal formations were produced by infusing different energy patterns into water using the Vital Force technological process. As you can see in the picture below, different energy patterns produced very different crystal structures. These experiments provide further confirmation that subtle energies, whether programmed by the mind or technologically can cause changes in the water’s structure and consequently in the shape of frozen water crystals.



4. **The results of #1 and #2 suggest that the “placebo” phenomenon may be an effect of the human mind’s ability to program subtle energy with healing intent and imprint that healing subtle energy into the body’s own “mineral solution”.** Functioning as software for all systems of the body subtle energy imprinted in this way can work for a long time after the thought process is finished and can have a significant influence on the outcome of treatment. Training patients to consciously program and direct subtle energy to the problematic area in their body, just as Pranic and Cosmo Energetic healers are already doing, might convert the placebo phenomenon into a powerful healing modality.
5. **The ability of liquid minerals (concentrated sea salt) to hold and receive through the Vital Force Technology™ equipment the healing, protecting and cleansing information encoded in subtle energy demonstrates the presence of an intricate and fundamental interaction between the subtle energy field and physical matter.**
6. **An energetically polluted environment drastically diminishes the healing effect of subtle energy.**
7. **Special protective and space cleaning energies can dramatically increase healing effects.** This suggests a new method for improving the effectiveness of various healing modalities.

As a final thought, I suggest that we all need to take another look at what we think we know about the laws of the Universe. These experiments have opened a window into what Lao Tzu described as a Universe filled with “numberless energy rays” by showing how responsive some of these numberless rays are to the commands of the human mind, whether these commands are made in words or imagery.
